This contract is entered into between Lindsay Klik LaBella (stallion owner) in Avon, New York and _____ (mare owner) for the breeding of Pietro Antonio DHA to _____ (mare).

1. Booking Completion, signing, and submission of this contract with a check made out to Lindsay Klik LaBella for \$ 250 as a booking fee will confirm a reservation. The booking fee is later applied to the full breeding fee. In cases of multiple mares needing shipped semen or live cover on the same day, priority will be according to how early the booking fee was paid.
 2. Breeding Fee The breeding fee for Pietro Antonio DHA is \$ 800. It is due before shipment of semen, or before the mare is removed from Dutch Hollow Acres after breeding or insemination. If a booking fee was paid in advance, the balance of \$ 550 is due at this time.



3. **Negative Uterine Culture** All mares who are to be bred live cover must have proof of a recent negative uterine culture. It is strongly recommended that AI mares also be cultured.
4. **Live Foal Guarantee:** If this breeding fails to produce a live foal that stands and nurses there is a return privilege available. The owner can re-breed the same mare or another mare that is approved by the stallion owner during the following breeding season by paying a \$ 250 booking fee for each year in which the mare is bred. This privilege expires after 2 years from date of this contract unless the stallion owner agrees to an extension. The breeding fee itself is not refundable unless the stallion dies or is no longer fit for breeding, or unless non-viable semen is shipped.
5. **Viable Semen Guarantee:** If shipped semen arrives within 24 hours of being shipped from Henderson Equine Clinic and the mare owner's veterinarian determines that the semen is not viable and the mare does not conceive, the mare owner is entitled to a full refund of both the booking and the breeding fee.
6. **Mare Care:** If the mare is left at Dutch Hollow Acres for breeding there will be a board charge of \$15 per day or \$20 per day for a mare with foal. The mare owner agrees to pay for any veterinary care during this stay, including but not limited to palpations and ultrasound to determine stage of estrous and pregnancy.
7. **Transported Semen:** Cooled semen will be shipped overnight upon payment of the stud fee. Collection and Shipping costs are to be made directly to Henderson Equine Clinic where the stallion is to be collected. The mare owner will notify the stallion owner when the mare comes in heat and has been palpated or had an ultrasound by a veterinarian. Barring unforeseen circumstances, semen can be collected and sent out Monday, Wednesday or Friday afternoons. Do not expect us to collect and ship semen on the day that you call.
8. **Collection Fees:** Are to be paid by the mare owner directly to the collection station Henderson Equine Clinic. It is advised to call 585-243-5560 and set up billing arrangements prior to collection to ensure timely shipment.
9. **Liability:** Neither the stallion owner nor mare owner, their agents, employees, nor the owners of Dutch Hollow Acres are liable for the death, injury, disease or accident caused to or by the stallion, mare, or foal. If the Mare Owner defaults in any obligation under this contract, the Mare Owner shall be responsible for all attorney's fees and costs incurred by Stallion Owner as a



result of said default. The Mare Owner's obligation for attorney's fees and costs are responsibility of the Mare Owner at law or in equity. This contract contains the entire understanding of the parties and may be modified only by a writing signed by all parties. This contract shall be construed and governed by the laws of the State of New York, and the parties expressly agree the jurisdiction and venue for any and all disputes arising under this contract shall be proper only in Livingston County, New York. In the event that Stallion Owner incurs attorney's fees and/or legal costs in securing or protecting any right available to it under this contract or under the laws of the State of N, the Mare Owner agrees to pay said attorney's fees and costs.
